

EXHIBITING CONDITIONS

1. All vehicles in the show must meet applicable Provincial and Federal safety standards, must have locked gas caps and have their engine batteries disconnected. All propane tanks must be empty, except with special permission. Exhibit products and materials must confirm to all fire and safety regulations established by the Municipal, Provincial, Federal and Tradex authorities
2. Exhibitors may bring in and use their own forklifts, but all forklift drivers must have proper certifications, and provide proof of that certification upon request.
3. Exhibitors may only exhibit, sell, or take orders for the products or services listed on their exhibit space contract. The Show Producer must pre-approve any additions or deletions to the list. The Show Producer may limit what products may be exhibited, to avoid duplication of exhibits.
4. **Exhibitors may not sublet, license, or in any other way assign their contracted exhibit space.**
5. Exhibitors intending to hold a draw or contest at the show must provide a copy of the rules and the entry form to the Show Producer on or before move in day. Winners for the draw or contests must be determined by the close of the Show, unless prior approval from the Show Producer is obtained. The names, addresses and telephone numbers of the winners must be provided in writing to the Show Manager by the end of the show.
6. As part of their exhibit space contract, each inside bulk exhibitor is provided with one 1500 watt electrical outlet for every two RVs. As part of their exhibit space contract, each booth exhibitor is provided with one duplex outlet per 10 feet of frontage. As part of their exhibit space contract, each small bulk exhibitor is provided with one duplex outlet per 20 feet of frontage. Additional power or lighting requirements are the responsibility of the exhibitor, and must be ordered directly from the official show electrical supplier.
7. **Exhibitors are responsible for carrying at least \$2 million in public liability insurance, which includes "MTD Promotions, a Division of Fraserway RV LP" as an additional insured.** The insured period is to include the move in and move out dates. Exhibitors must provide written proof of insurance to the Show Producers by move in day. Exhibitors will be liable for, and will indemnify and hold harmless the Show Producer and Show Management, of any losses or damages whatsoever suffered by anyone or anything as a result of the Exhibitor's participation in the show.
8. The Show Producer shall not be liable in any way for failure to carry out any of the terms of the Exhibit Space Contract where caused directly or indirectly by anything such as fire, storm, flood, war, insurrection, riot, civil commotion or labour strike or disruption, etc if the contracted space for the period of time the Show Producer decided it was unusable
9. The Exhibitor agrees to observe all union contracts and labour regulations in force, agreements between The Show Producer; official show service companies and Tradex, and the labour laws of jurisdiction in which the show facility is located.
10. The Show Producer has the right to cancel the Exhibit Space Contract if the Exhibitor fails to perform any material condition of the Contract, or refuses to abide by the Exhibiting Conditions of the show. In this case the Exhibitor shall forfeit all monies paid for space rental as liquidated damages, and shall vacate the contracted exhibit space as directed by the Show Producer.
11. The Exhibit Space Contract may be cancelled by either party provided written notice is received by the other party, however if the Exhibitor cancels, they will be liable for 100% of the contracted space rental charge. No refunds will be given unless the Exhibit Space Contract is cancelled by the Show Producer. By canceling the Exhibit Space Contract the Exhibitor forfeits all rights or claims to the allocated space and the Show Producer is free to rent the space to others.
12. Where approval of the Show Producer is required in these conditions, such approval may be granted or refused in the sole discretion of the Show Producer or their appointed agent.
13. The Exhibitor agrees to abide by these Exhibiting Conditions and may others the Show Producer may deem necessary from time to time, before, during and following the show.
